g- Exercise your rights

We inform you that you can exercise the following rights for free, by email to cape@cape.es attaching a copy of your ID or equivalent document.

The rights you can exercise are:

Access: Consultation of the personal data made available to Mecánica Cape S.L.U.

Rectification: Modify your data if they have changed, are inaccurate or incomplete.

Erasure: Request to delete your data.

Objection: Request for your data not to be processed.

Restriction of processing: Request the restriction of processing of your data while:

-Its accuracy is checked (challenge)

-If there is unlawful treatment but you do not want the deletion of your data.

-If Mecánica Cape S.L.U. does not need your data but you want to keep them because they are necessary for the exercise of your defence or claims.

-When once a right of objection has been requested, it is being verified whether this right prevails over a public or legitimate interest that affects the data that is grounds for objection until the resolution of the conflict.

Portability: Power to receive the data provided by you in electronic format and those obtained during the contractual relationship with Mecánica Cape S.L.U., as well as its transmission to another organisation.

Claims: If you consider that for any reason Mecánica Cape S.L.U. has not correctly processed your data in accordance with current regulations, you can contact the Security Officer at cape@cape.es who will attend and process your claim with utmost diligence, you can also, if deemed appropriate, file a claim by contacting the Spanish Agency for Data Protection.
